- 4) Area of Operation :- Jalgaon District.
- 5) According to the Constitution of the Society the first executive committee will be as follows and the following members have formed the Society i.e. Iqra Education Society, Jalgaon. - b) Re-admission :- Any member removed or resigned, may be re-admitted in the same category under the rules.

5. General Body :-

- i) The General Body of the society shall consist of the Founder Members and the Life Members.
- ii) The General Body meeting will be called soon after the commencement of the year, by President or Vice-President but within 3 months thereafter i.e. upto 30th June.
- iii) The General Body meeting will discuss the last year report and budget for the next year.
- iv) To elect, whenever due, the Office bearers and members of the committee in accordance with the bye-laws for the election.
- v) To make amendments and cancel any bye-law and regulation for the administration of the different wings of the Society.
- vi) A notice of the General Body meeting will be circulated to all the members at least not less than 7 days before the commencement of the meeting. One notice will indicate the time, date, place and agenda of the meeting.
- vii) At any general body meeting the quorum shall be 1/3rd of the total number of the members. For want of quorum, the President shall adjourn the meeting. The adjourned meeting shall be conducted after 15 minutes on the same date and place, and shall require no quorum.
- viii) The General Body shall be the Supreme Body of the Society and the decision taken by it shall be followed by the Executive Committee.
- ix) Special General Meeting:- Any special general meeting shall be called for on the demand of at least 1/3rd of the members of the executive committee.
- x) Every question submitted to the meeting shall be decided by simple majority.
- xi) In case of equality of votes, the President shall have right to cast an additional vote (other than his own vote).
- xii) In case as mentioned in clause ii, if General Bod-

meeting is not called by the President/ Vice-President within the stipulated time, on requisition of any 9(nine) members, the Secretary shall call General Body meeting. The first E.C. mentioned in the Memorandum of Association shall hold the office till for 5 years after the date of Registration of the Society.

6. Executive Committee :-

- 1) The Executive Committee of the Society shall be elected after every 5 years in a General Body meeting and it will consist of :

i) President	One	from Founder Member
ii) Vice-President	One	do
iii) Secretary	One	do
iv) Jr. Secretary	One	do
v) Treasurer	One	do
vi) Elected Members	Six	do
		Two -----Life Members.
vii) Co-Opted "	Two	do

- 2) Further, the Office Bearers of the Society shall be elected ~~xxmmxbms~~ amongst the founder members only at the General Body meeting. Similarly two members of the executive committee of the society shall be elected amongst the Life Members, at the same General Body meeting.
- 3) Any teacher ^{employee} serving in the institution run by the Society, shall not hold any post of the Executive Committee of the Society.

7. Powers and Functions of the Executive Committee :-

- 1) The meeting of the Executive Committee shall be called for at least 6 times a year. A three days' notice will be given to the member. Such notice shall contain the day, date, time, place and agenda of the meeting.
- 2) Quorum:- Any five members of the Executive Committee shall form a quorum. For want of quorum the President shall adjourn the meeting for half an hour, and ~~xxmxx~~ shaikhha no quorum shall be required for the adjourned meeting.
- 3) An Urgent meeting:- An urgent meeting of the Ex

Executive Committee may be called by the President on his own initiative or on receipt of a written requisition of any three members of the Ex. Committee addressed to President. In such a case a written notice of at least 48 hours shall be given to each member of the Committee.

- 4) Non-receipt of the notice by any member of the Committee shall not invalidate the proceeding of any meeting.

5)

Powers of the Executive Committee.

The Executive Committee shall have the following powers :

- 1) To discuss and decide the questions and problems related to the aims and objects of the society.
- 2) To try to get subscribers, donors and grants for the Society.
- 3) To prepare and to put forth and sanction the annual report and expenditure record and the next year budget at the General Body Meeting.
- 4) To decide the points for calling the general meeting.
- 5) To undertake the legal procedure for the benefit of the Society.
- 6) To make representation in the matters of correspondence to the Government and its officers.
- 7) To appoint sub-committees when needed.
- 8) To appoint the Staff for institution and get their appointment and scales from the Government.
- 9) To check the accounts of the Society and its subordinate institutions.


Capital :-

i) The whole property and all funds of the Society shall be of the society as a whole and not of the particular members thereof.

ii) An account shall be opened in the nationalized Bank/Banks at Jalgan in the name of the Society to be operated jointly by the Treasurer with the Signature of either of the President or Secretary.

- a) Grants, Donations, Subscriptions.
- b) Debts and loans taken.
- c) Society's building and Dead Stock.
- d) Income from social functions and any other means approved by the Executive Committee.

9. Powers and Duties of the Officer-Bearers:-

The Powers and Duties of the Office Bearers are as under:-

- A) PRESIDENT:- The president shall be the Head of the Society, and as such shall have all executive powers as given below.
- i) To implement the resolutions of the General Body and the Executive Committee from time to time.
 - ii) To carry on the activities of the Society including such activities as may be conducive to the advancement or fulfillment of the society.
 - iii) To allocate duties and functions amongst the Secretary and Treasurer as and when necessary so as to co-ordinate their respective services.
 - iv) The President and the Secretary shall be Ex-Officio members of all the sub-committees that may be appointed from time to time.
 - v) The President shall in the place/places falling vacant due to the resignation or death of any founder member with the consent of the 2/3rd founder members.
 - vi) If any vacancy occurs in the Executive Committee due to resignation, death, removal etc the president shall fill in the vacancy for the remaining term of the Executive Committee with the consent of the 2/3rd members of the Executive Committee.

B) VICE-PRESIDENT :-

- i) The Vice-President shall, in the absence of the President, perform all the duties and functions of the president, for this purpose he shall also have all the powers, rights and the functions of the President, whenever the president is officially out leave.
- ii) The Vice-President shall perform such duties and functions of the president as may be directed for the time being.

C) SECRETARY :-

- i) To place and carry out the organisation and further development of the Society.
- ii) To raise and collect funds.
- iii) To supervise the working of the Society.
- iv) To record the minutes of all the meetings of the General Body and Executive Committee and Sub-Committees that may be formed from time to time.
- v) To attend to the legal affairs of the society.
- vi) To conduct all the correspondence of the society.
- vii) To prepare jointly with the treasurer the budget of the Society.
- viii) To convene the meeting of the Secretariat Committee with the consent of the President and prepare the report of the Society.

D) JT.SECRETARY:-

He shall assist the secretary in discharge of his duties, and perform such duties as may be entrusted to him by the Committee from time to time.

(E) TREASURER :-

- i) To maintain regularly the books of accounts of the Society.
- ii) To supervise, check and control the books of accounts maintained by the Society.
- iii) To prepare jointly with the Secretary the Budget of the society.
- iv) To maintain annual inventories of the properties, both movable and immovable belonging to the Society. So also of the Documents and other important Papers.
- v) To report to the Executive Committee the President or in his absence, the Vice-President the state of finance of the Society and perform such other duties and functions of the Society relating to the finance and accounts as may be prescribed by the President.
- vi) To get the accounts audited at the close of the year for being placed for approval of the Annual General Body meeting.

10. Alteration of the Rules :-

- i) Proposals to move resolutions embodying such alterations or amendments or additions to these rules/any General meeting must reach to the Secretary of the Society on or before 31st of May every year. All such proposals shall be circulated to the members as a part of Agenda for such meeting
- ii) Alterations, amendments or additions to these rules shall be made by a resolution carried by the majority of 2/3rd of the votes of the members of the G.B. present at the ~~General Body meeting~~ ^{Gen. Body} Special meeting

11. Reservation Co-Option :- The Executive Committee may ~~allow~~ co-opt not more than two members whenever and wherever required.




